1. Adoptive parents must abide by all DPPR policies and procedures.
2. As an adoptive parent, I will provide all at my own expense, time, proper and sufficient food and water, shelter, kind treatment. I understand that I shall not leave the animal(s) unsupervised outside for any length of time. And see to it measures are taken to guard your pet from any obvious potential hazards that may cause injury or premature death.
3. I fully understand that DPPR makes no guarantees whatsoever as to the health, temperament, mental disposition, and training of the animal(s).
4. DPPR will be allowed to reasonably inspect the premises in which the animal(s) will be maintained or are maintained, from time to time, for the purpose of determining the suitability of those premises for the care and maintenance of the animal(s).
5. This Adoptive Parent Agreement, the Adoption Application, and the Statement of Understanding, Release of Liability, Waiver of Claims and Assumption of Risk Agreement, contain the full and complete understanding between the adoptive parent and DPPR and supersede all prior agreements and understanding pertaining hereto and cannot be modified except by a writing signed by each party. Those agreements shall each be governed by the laws of the state of which the adoption occurs.
7. I agree that I will not place the adopted animal(s) in any dangerous situation (e.g. riding in an open pick-up truck or left unattended in a car, tethered outside or left in a car while running errands). I agree dogs will not be used as guard, hunting or fighting dogs. Cats **unless specified will not be used as mousers.
8. I agree that I will keep the adopted animal(s) in the house as a loved family member. If cats are feral or barn cats, adequate shelter, food, water, and medical care shall be offered.
9. I agree that I will keep all adopted cats and kittens as predominately in door pets (unless specified) and shall never be relegated to the garage, basement, barn etc. If, however you feel the need to do so, please contact DPPR to discuss the issues that may warrant such actions.
10. I agree that I will keep all adopted dogs and puppies in a secure area, and that I will not allow the dogs and puppies off-leash except in a secure fenced in area of my property. I agree to provide adequate exercise and socialization for the adopted animals.

11. I agree that I will not use chains or other devices to tether the animal as a means of confinement.

13. I agree to feed, water, groom, exercise, and socialize the adopted pet(s) as appropriate. I agree to never hit, kick, or abuse the animal in any way.

14. I agree not to tie the animal out either in front of a store or anywhere on the property of the adopted home.

16. I agree that I have committed to providing for the adopted pet(s) at my expense for routine care as well as emergency care.

17. In the event of my death or incapacity, this Contract shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives.

All of the information I have provided on this application is, to the best of my knowledge, true and complete. I understand that falsifying information on this agreement or non-compliance with any of its terms at any time during the adoption process may disqualify me for eligibility as an Adoptive Parent.

I hereby understand and agree to all of the foregoing terms.
